


How the REPASACK system works:

You agree to the use of a trademark with us.

The REPASACK symbol is a registered trademark and may only be used in combination with a customer-specific registration number. This prevents all forms of misuse. You either buy the licence and authorise a paper sack manufacturer to print the REPASACK trademark on your paper sacks, or you buy licensed paper bags directly from the paper sack manufacturer.

A REPASACK symbol is available for every industry: it is the "return ticket" for the paper sack.



After being sorted according to product content groups, the paper sacks are sent for material recycling.

Hazardous substances or pollutants? No problem!

To transport products that contain hazardous material in paper sacks, we offer the **REPASACK-G system.** The "G" stands for "Gefahrstoff", which is the German word for "hazardous material".

Legal certainty for you – **convenience** for your customers

The take-back of your paper sacks is ensured across the board.

REPASACK stands for REcycling-PAper-SACK.

We organise take-back and recycling services for manufacturers, distributors, fillers and consumers who handle kraft paper sacks – i.e., your customers. Whether it is for cement or chemicals, seeds or animal feed, sugar or flour – kraft paper sacks are used in many industries, and eventually have to be disposed. End consumers can dispose their completely emptied REPASACK paper bags free of charge at the approx. 350 acceptance and collection points that we maintain throughout Germany.
