



## Data protection notice

### Personal data

It is not necessary to provide personal details when visiting our website. If individual functions and services on our website require personal data to be provided, saved and used, you will be specifically informed of this in advance. Personal data is only collected, saved and used for our own marketing and advertising (no cold calling) if you have given your consent for this. Data is only passed on to third parties if you have given your prior consent or if this is simply for contract data processing. ### Technical information and cookies

If you access our web pages, technical access data will automatically be logged and analysed by our server (e.g. the web browser and operating system used, domain name, previously visited websites, average time spent on the website and pages accessed from our website). The individual user remains anonymous whilst this data is logged and analysed. It is used to improve the design and usability of our website and its content, and to detect problems our website may have.

We also use cookies in several different places. Cookies are small text files that are installed on your computer that your browser saves. Cookies cannot be assigned to certain persons and do not contain personal data. This data is not merged with other data sources. Regardless of the type of cookies used, you always have the choice to decide whether you want to accept cookies or not. You can change your browser's settings so that you are notified when you receive a cookie or you can exercise your legal right of objection to the use of cookies by rejecting cookies in the browser settings. Cookies that have already been saved can be deleted by using this function in your browser. You can find details of how to do this in your web browser's help function. Notes on Google Analytics

This website uses Google Analytics, a Google Inc. (“Google”) web analysis service. #### Notes on Google ReCAPTCHA
